#### JUDGMENT MAY BE TAKEN AGAINST YOU IF

- (a) YOU FAIL to file the Appearance within the time for appearance provided for below, or
- (b) YOU FAIL to file the Statement of Defence within the time for defence provided for below.

#### TIME FOR APPEARANCE

If this Notice is served on a person in Yukon, the time for appearance by that person is 7 days from the service (not including the day of service).

If this Notice is served on a person outside Yukon, the time for appearance by that person after service is 21 days in the case of a person residing anywhere within Canada, 28 days in the case of a person residing in the United States of America, and 42 days in the case of a person residing elsewhere.
